## GENERAL REGISTRATION INFORMATION FOR 3-YEAR-OLD CLASSES

Tuition fees: 3 days/wk - \$210.00/month; 4 days/wk - \$240.00/month; 5 days/wk - \$265/month

Children must be three years of age on or before August 31, 2011 in order to enroll in the 3-year-old classes, with the exception of children who were previously enrolled at SPP and are being "grandfathered" due to the change in cut-off dates from October 16 to August 31.

One 3-day class (Monday/Wednesday/Friday), one 3/4-day class (Tuesday through Thursday, Friday optional\*), and one 4/5-day class (Monday through Thursday, Friday optional\*) will be offered. Fridays will be optional only during the fall semester. Beginning in January 2013 Fridays will automatically be added for all students and charged accordingly.

In order to guarantee your place, the first month's non-refundable tuition is due no later than May 15, 2012 (or upon registration at a later date). Tuition is paid one month in advance. Registration fees are non-refundable, except for those moving out of town prior to August 1, 2012.

# SPP Registration Worksheet

Thank you for completing the following worksheet to determine your rank for placement in the St. Paul's Preschool registration process. Once the information provided has been confirmed and applications have been reviewed, class assignments will be made in order of point totals. *Active* parishioners of St. Paul's Episcopal Church will receive priority based on length of membership (see below). As always, any child currently enrolled at St. Paul's Preschool is guaranteed a space (not necessarily first choice) for the 2012/2013 school year.

Every effort will be made to accommodate your wishes and the needs of your children. However, we can no longer honor requests for certain teachers. An attempt will be made to equalize the number of boys and girls in a class, and this may cause the point count to be out of balance. Days for Tiny Tots will be matched with those of older siblings. The preschool director, assisted by teachers and/or board members will determine overall placement. In the event of a tie for one remaining space in a class, the following facts (in this order) will be used to determine placement: 1) Total number of years the family has been at St. Paul's Preschool, 2) Parent is a St. Paul's Preschool alum, 3) Child has siblings currently enrolled at SPP, and 4) Child enrolling had a sibling(s) previously enrolled in the class.

**PLEASE NOTE**—St. Paul's Preschool welcomes families in our community who are not currently affiliated with our church or our preschool. For those who are not parishioners of St. Paul's Episcopal Church, do not have a currently or previously enrolled child, or a parent is not an alumnus of St. Paul's Preschool, this pre-enrollment worksheet will not apply. Therefore, openings within the preschool (after affiliated persons have registered) will be available for other interested applicants to **register in person** on Monday, February 27, 2011 beginning at 10:00 AM.

[Non-affiliated out-of-town applications may be mailed in (postmarked by February 17, 2012). Email is not an option as a registration fee check is required. In situations where individuals are moving to Winston-Salem at a later date and are currently living out of town, a number, drawn at random and based on the number of mail-in applications plus the number of people in line at 10:00 AM on the day registration opens to the public, will be assigned to the mail-in applications.]

## St. Paul's Preschool 2012 REGISTRATION DATES

**Wednesday, February 15** Absolute deadline for registration of **children of active St. Paul's parishioners** (communion 3 times/year, paid pledge to St. Paul's, and member more than 1 year), **non-parishioner children currently enrolled and their siblings, siblings and/or children of alumni,** and **new parishioners of St. Paul's Episcopal Church** (less than one year membership). Points must be tabulated (see above) in order for the application to be processed. Applications plus registration fees may be hand-delivered to the preschool office or mailed (postmarked by February 10th) to:

**Monday, February 27\* PUBLIC REGISTRATION** **Registration opens to the public at 10:00 AM in the Youth Room** (West Entrance off back parking lot, first floor, follow signs). Beginning Monday, February 20 available spaces in each class will be listed on the preschool tab of the church website, [www.stpauls-ws.org](http://www.stpauls-ws.org). You may find out which classes still have openings and how many spaces remain. (Very early arrival for registration is strongly discouraged, as there is no onsite security overnight.)
