Parents and Guardians must sign the DIGITAL MINISTRY AND CONSENT FORM

Concerning Online Learning. Parent(s)/guardian(s) and child should adhere to the following approach to online/virtual learning with our religious education program. The Director of Religious Education or the catechist may add or delete items as the class progresses.

1. Parent(s)/guardian must set aside a day and time to log in for the weekly lesson. This means day and time with no or least distraction such as TV, et
2. Parent(s)/guardian must log in with and for the child.
3. Child is not allowed to log in for himself or herself
4. Parent(s)/guardian must set up an environment conducive to learning and praying (example: TV set or any electronic game must be off during the session, place a Bible, cross or crucifix on the table, if you have one).
5. Parent(s)/guardian and child must keep up with the pace of weekly session. Do not handle more than one lesson in one sitting
6. Parent/Guardian must ensure the child is focused on the session at hand and not attending to another activity (online games not connected with the lesson, etc.) or homework or work for the child's regular school
7. Parent/guardian ensures the child finishes the lesson and e-assessment, if there is any, in a timely manner.
8. All e-assessments, video-recorded messages, and all forms of communications between the catechists and the families must adhere to common sense decency, appropriate, and in response to the lesson being discussed. Personal opinions and inappropriate comments are not allowed
9. Items 1 to 8 will also apply for Safe Environment Training mandated by the United States Conference of Catholic Bishops
