## **Computer Proficiency, UDTSlarning.net and the CRE Process**

PEVA's CP program involves a significant amount of online study. The online component of this program is offered through UDTSlarning.net (a program for online learning through the University of Dubuque Theological Seminary). After you have been approved to be a candidate in PEVA's CP program, you will be expected to take eight core courses required of Presbyterian CP's (i.e., Introduction to Old Testament, Introduction to New Testament, Pastoral Care, Presbyterian Polity, Reformed Theology, Introduction to Preaching, Foundation of Christian Education and Reformed Worship & Sacraments). After you have successfully completed all of these courses, you will meet with the CP Committee for a final exit interview and examination.

## **Annual Review**

If commissioned, there will be an annual review with the CP candidate and a report required from the CP mentor. The review will be conducted by the members of the CP subcommittee and will cover concerns, issues and progress.

## **Statement of Consent**

I am applying to the Commissioned Pastor program of the Presbytery of Eastern Virginia. If accepted, I commit myself to participating fully in the scheduled activities and assignments to the best of my ability. I understand that successful completion of CP training is necessary before one can be commissioned as a CP. I also recognize that completion of the educational portion of the program does not guarantee certification or a position as a CP. Certification and commissioning depend upon a successful interview and endorsement of the Commission on Ministry.

I understand that the Presbytery of Eastern Virginia and/or any local congregation to which I may be commissioned must conduct a criminal background check or other screening it deems necessary and appropriate.
