# PRESBYTERY PROGRAMS/ACTIONS

Received a presentation by the Reverend Berthe Kalombo Nzeba, or Maman Nzeba as she is more popularly known among Congolese church women. Rev. Nzeba is the General Secretary of the Women and Families Department of the Protestant Church of Christ in Congo, Eglise du Christ du Congo (ECC). A Presbyterian minister ordained in 1978, she is believed to be the first female Protestant clergy in the Democratic Republic of Congo. Rev. Nzeba requested

that American Presbyterians contact their political leaders to demand that American corporations cease removing the Democratic Republic of the Congo's natural resources without fair compensation.

# GENERAL PRESYBTER REPORT

The Reverend Elizabeth G. "Liza" Hendricks reported on the good works of the ministers and congregations of the Presbytery. Rev. Hendricks noted that Green Acres Church, Portsmouth, has decided to shift their stewardship emphasis from money to mission and to focus on celebrating their ministries. The Hilton Church in Newport News organized officer training for the churches on the Peninsula that was so well subscribed the event had to be moved to a larger meeting room at Hidenwood Church. Naomi Makemie Church, Onancock partnered with Holy Trinity Episcopal Church to conduct Vacation Bible School (VBS) for the first time in ten years. 25 children were students of VBS and four families began attending Naomi Makemie Church as a result of this community outreach. Wycliffe Church, Virginia Beach completed the renovation of their sanctuary, administration building and impressive steel girder Cross which is in the church yard. The dedication service for the renovation featured the participation of the General Presbyter.
