**Ministry Area Reports**

A. **Children's Ministry**—submitted by LeAnn Sapp

Pathways has found its school year rhythm and has regular attendance of 28-32. We began the year learning about the Fruits of the Spirit and how we can actively use them in our life, even when it's difficult. Our current unit is focused on the story of Hannah, Samuel, and Eli with an emphasis on listening and being ready when God calls us.

Worship and Wonder had a regular attendance of 3-6. Instead of separating into the 2&3 and 4&5-year-old classrooms, we will remain combined in one classroom due to low attendance numbers. Claire Willard and Chuck Davis will continue as primary classroom leaders with a small support group of parents stepping in when needed. We will re-access classroom needs at the new year or as needed.

JYF (Junior Youth Fellowship) Met in September with nine 3-5th graders participating in the crop walk at Stephens Lake park. We discussed that even when we have little to give ourselves, we can still make an impact by standing in support of those in our community.

Debbie Rauch will be stepping down as Children's Ministries Assistant effective December 22. She has been a gift to Aimee and Children's Ministries these last two years and every stride our ministry has made is due in large part to her support and attention to detail. We will have a public thank you during service on Children's Sunday, December 15.

**FUTURE DEVELOPMENTS**

Trunk or Treat & Grilled Cheese and Tomato Soup Dinner will be on October 27. We are currently in need of a few more trunks. Not only is this an evangelical opportunity for the church, as many families that participate are not Broadway members, but it is a great opportunity for fellowship with everyone who attends.

Christmas Pageant Rehearsals will begin November 3rd and run weekly until December 8. Culminating in Children's Sunday on December 15. Kay Cook has written an original play Titled, "Fred the Shepherd," Currently we have 24 Elementary Children signed up, as well as 7 middle school youth to sing in the support choir. Ryan and Kimberly Kenney will offer their support as co-directors as well this year.

Family Advent Party will be held during the Sunday school hour in lieu of Pathways and Worship and Wonder. This event is only successful with parent participation as we will have 4-5 crafts set up and several games that are self-led.

We will be posting the Children's Ministry Assistant position in the next week or so. The position is 15 hours a week, with the need for more around vacation Bible School. If you know of someone who would like to serve the children of this church, is detail oriented, and is comfortable working independently but also as a team, please keep them informed as we move forward with process.

#### QUESTIONS FOR OR REQUESTED ATTENTION OF THE BOARD

Concerns about care and use of sanctuary piano. Request for a committee to establish policy/procedures regarding piano use (lock, stipend for person to supervise use, cost/liability for use of piano by outside groups), professional consultation regarding piano maintenance, replacement estimates. The piano needs significant repair. The cost to repair is more than the annual budget for piano maintenance. It may have to be replaced. This may be an item for a special funds request or possibly a request from permanent funds.

#### **Membership Report**

Ingrid reported the addition of one new member in the month of October. As of October 31, we have 594 active members. Some members who had become inactive have begun attending again and are now counted as active once again. Total Membership (Active/Inactive) stands at 666.

#### **Financial Report**

Martha Head reported a net balance of \$23,584.83 for the month of September. \$8,100 was paid for MOM distributions, which will be reflected in the October numbers.

#### **Executive Committee Report** –Steve Westgate

The request for BCC to serve as Chartering Organization for Venturing Crew 3343 and to provide a meeting place was approved at the September Executive Committee meeting.

Job descriptions are being written for the All God’s Children coordinator and a Children’s Ministry assistant.

The new Visioning process will begin in the spring under the direction of Deb Ward. Suggestions of members to include in the process are invited. We will be seeking a wide representation from different areas of ministry and new as well as established members.

It has been gratifying to note that some in the local LGBTQ community have publicly expressed appreciation of Broadway Christian Church. In response to the local controversy over a recent sermon at the Crossing Church, Mark, Nick and Terry drafted a response that was posted to FaceBook and has been widely shared with 4,000+ views.

The upcoming Trunk or Treat is a good fellowship opportunity. It generally draws families from the neighborhood in addition to church families, and the soup and sandwich supper has been well attended by all ages.

Rehearsals for the Christmas pageant have begun. Kay Cook has written the play. Kay makes a point of including parts for the different age groups.

In advance preparation for Advent, the new sermon series will explore “creating margins” in your life.

**Terry Overfelt** encouraged participation in the Community Day of Prayer to be held at Broadway on November 16, 8:00-5:00. This has been the vision of Joe Pallikkathayil, a former Broadway member. Advance registration is encouraged.

Retreats are being planned for February.

The Blue Christmas service will be held the first Tuesday of December with artist Vesna Delevska participating
