## **Deacons Report –Sally Daniels**

Reviewed the duties of Deacons. Emphasized the work of the Events Committee; Laurel Raymond and Nancy Delagoustina will lead it. Starting to plan the St. Patrick's Day dinner.

Discussed sending cards and flowers. Nancy D sent handwritten Christmas cards to all members over 80 years old. Brook Bozeman presented on Camp Woods.

So far, the elders have had questions. The key is to connect the questioner with the person with the answers. The goal is to help the congregation be heard.

## **Ministry Reports**

• Missions – Jill Williamson

- Missions ministry thinks we need to interconnect across ministries. Different members from missions plan to request to attend other ministry meetings.
  Missions would love to have others attend their meeting.
- o Jill Williamson indicated Winter Relief is still in need of volunteers
- Welcome Doug Nauman
  - Sarah Wilson went over the summary of Elder Responsibilities
- Worship and Sacrament Jim Falvey
  - O A fund was previously established in Nancy Saarlas' name, as she was a long time Christian educator. The fund has been used to support the art ministry. The arts committee decided to formalize a policy for administering the fund. Jim Falvey will find out whether the art on display is covered by Church insurance, in case of loss or damage.
    - MOTION to approve the Saarlas Gallery Fund Implementation Guidelines (attached)

## MOTION APPROVED

 Jim described the need for repairs to the organ and the desire for a Harpsichord to perform baroque music.

MOTION to approve using funds from the Choir Fund to make organ repairs and to purchase a harpsichord, each expected to cost approximately \$4,000 for a total authorized amount of up to \$8,000.

#### MOTION APPROVED

- Stewardship & Finance Keith Kintzley
  - o Financial update − YTD net income is still good. Revenue is below budget but so are expense. We are now \$43k ahead YTD.
  - Stewardship season is coming up. Ministries will be asked for an asking budget. We plan to allow the congregation to review/comment on the asking budget.
  - Financial Review Results Endowment Fund principal usage. Keith indicated we have a fresh set of eyes doing the annual financial review. They found that we have been drawing principal from the permanent endowment fund for at least 16 years. Tom Lerario found records that the principal should be ~\$1.6M and it is now ~\$1.1 as a result of the routine withdrawals allowed in the Lasting Legacies Fund. But the Faith fund does not have as restrictive of a covenant. Finance plans to modify the Lasting Legacy Policy for a vote in February. The budgeted withdrawal from the Endowment Fund this year will be postponed until June so its need can be evaluated.

Session discussed the need to and potential plans to reimburse the Endowment Fund. It was recommended that further information be gathered, options be further evaluated, and a plan for communication of the issue be developed prior to a vote.

- Human Resources Jeff Ferguson
  - Updates on filling vacancies
    - Interviews/auditions have been underway for the position of Contemporary Music Director. Not ready yet to make a decision.
    - Have restarted the advertising process for Missions Director;

- Youth Director search committee list is almost complete. The goal will be to fill it by the summer.
- HR feels that systems and procedures are deficient and/or not well implemented at Woods, which can cause inefficiencies. HR is hiring Tom Wilke as a part time, 20-hr/week consultant to make improvements to administration. There were discussions of whether any potential improvements identified would be effective without an administrative manager to implement, and whether the cost is appropriate at this time. HR feels there is much benefit.
  - Tom will have a specific set of tasks to perform from HR. Bill Brook asked that he develop an effective org chart for the church and procedures for the bulletin. This unbudgeted salary/stipend cost would be covered by vacant staff position salaries.
- o Indicated that staff and their responsibilities and elder and deacon names will be listed in the bulletins to improve communication with the congregation.
