Dear Parents,

Thank you for your interest in Deltona Christian School. We believe a Christian education is the best investment a parent can make for their child. DCS was founded in 1974 as a ministry of Faith Baptist Church for the purpose of providing an excellent, Christ-centered education for families in the Deltona area.

Open enrollment for the 2016-2017 school year begins March 8th.

The registration process includes the following steps:

1. Schedule meeting with the Principal - Bring Discipline and Academic Records.
2. Enrollment Placement Exam - \$60.00 for K5 - 9th grade.
3. Pay registration fee and turn in completed Student Application
4. Turn in birth certificate, immunization records, and recent physical
(The physical must be within the last year.)
5. Attend one Sunday School and Morning Service at Faith Baptist Church (9:45 and 11:00 a.m.)

Deltona Christian School will reimburse families for the winter wear uniform jacket that is required for each student. This reimbursement will be made as a credit on the account. Parents can bring a receipt to the school office for the reimbursement credit to be made.

The registration fee must be paid before we can reserve a spot for your child. The supply fee is due by **June 1** and pays for your child's textbooks and initial school supplies. There are three options for paying tuition. Tuition may be paid in 10 or 11 monthly payments, July 1st or August 1st through May 1st. When choosing the 11 month payment plan, there is a 10% discount off the total tuition if you have a second child in school and an extra 5% for each additional child after that. There is a 5% discount for paying the tuition in full before the beginning of school. Tuition payments are due on the first of each month, and will be considered late after the 15th of each month.

Once we have received records from your child's previous school and your child has taken the placement exam, we will make a determination regarding enrolling your child.

We are looking forward to the opportunity of partnering with you for the purpose of offering your children an excellent education in a Christ-centered environment!

BEFORE AND AFTER SCHOOL CARE

Extended care will be provided at a cost of \$2.75/hr. for one child or \$2.50/hr. for two or more children. Any children dropped off between 7:00am and 7:45am or children not picked up 10 minutes after dismissal will automatically be checked in to extended care. After school care closes promptly at 6:00pm.

DRESS CODE

Students wear uniforms purchased from Sunshine School Uniforms. Girls in K3 through 5th grade wear polos with navy blue skirts, and boys wear polos with navy blue pants. Girls in 6th grade through 12th grade wear polos with khaki skirts, and boys wear polos with khaki pants. All students should wear shoes that enclose the foot.

PARENTS' STATEMENT OF COOPERATION

1. I understand that, as a matter of policy, DCS does not give refunds for registration, supply, sports, tuition, lunch, or daycare fees. This includes paying for a full or partial year of tuition in advance.
2. I will support Deltona Christian School financially by making all payments as due. Should I fail to make a payment on time, I am willing to accept any fees or penalties ascribed to overdue accounts.
3. I agree to purchase the appropriate clothing from Sunshine School Uniforms and ensure that my child is in dress code when on school property or attending school-sponsored activities.
4. I agree that discipline is necessary for the welfare of each student, as well as for the entire school. Therefore, I give permission for my child's teacher and/or an agent of the school to make and enforce classroom regulations in a manner consistent with Christian principles and discipline as set forth in the Student Handbook (DCS does not use corporal punishment).
5. In the event of illness or injury, I give Deltona Christian School the authority to make decisions concerning medical treatment for my child. I further agree to pay all medical expenses and other fees incurred in the course of an emergency.
6. I will not hold the school and its agents liable to my child or any guardian or parent thereof for any claims on behalf of my child against the school or any agent thereof due to any injury or alleged injury to my child. Should legal action, for any reason, be taken against Deltona Christian School or any agent thereof on my child's behalf and the school or its agent not be found at fault, I agree to pay any attorney fees, court fees, damages, and other costs that Deltona Christian School or its agent should incur in defending itself against such action.
7. I give my child permission to participate in all school activities, including field trips, sports activities, or any other school-sponsored trips away from the school premises.
8. I give permission for my child to be photographed or videotaped in the course of school activities and also give DCS permission to use those photographs in promotional materials such as the website, brochures, etc.
9. I understand that DCS will not forward my child's academic records if my account is not paid in full.
10. I understand that the Student Handbook is not all inclusive and that decisions may be made as determined by the administration. I have read the Student Handbook in its entirety and agree to abide by all guidelines set forth therein.
11. If I am a parent of a scholarship student, I understand if I withdraw my child before the end of the school year, I may be required to pay the balance of the registration fee, supply fee, sports fee, music lesson fee, and/or field trip fee.
