## **RULES AND REGULATIONS**

1. All Members and guests shall be expected to wear proper attire, i.e. shorts, t-shirts, footwear when using the club.
2. Valuables cannot be left at the front desk.
3. Lockers are available for monthly rental;
4. When playing racquetball, Non-scuffing tennis shoes must be worn on the racquetball court. (no dark soled shoes)
5. Do not drop weights (dumbbells or plates). Return all weights to their rack immediately after use. Do not leave dumbbells or weights on floor. No weights of any kind are to be moved from the free weight area. No weights are to be added to the weight machines. Do not move weights, benches or equipment from their proper location.
6. If a machine jams or a pin is stuck please notify an employee immediately. Please notify an employee of any needed repairs.
7. There is a 20-30 minute time limit on the cycles, rowers, and stair masters when another member is waiting to use them.
8. No food is allowed in the exercise areas. Plastic bottles with drink are permitted.
9. When waiting for an aerobics class to start, please do not crowd the ending class. Allow the ending class to clear the aerobic floor before taking your place.
10. No profanity of any kind is permitted in the facility.
11. Damage to club property shall be paid for by any member who willfully or neglectfully causes such damage and any such amounts shall be added to the member's account. Members are responsible for damage or loss incurred by their guest or dependent children.
12. If any check or draft payable to the club is not honored, in addition to the other rights it may have, the club may have the right to assess a charge in the amount of \$20.00 for each check so dishonored.
13. Members shall abide by club reservation policies.
14. Guests must pay a guest fee unless a guest pass is presented.
15. The club reserves the right to establish the reservation policy as well as the hours and days of operation of the facility.
16. All members and guests must abide by posted exercise rules in all exercise areas.
17. On all questions concerning rules and regulations, the decision of the club are final.
18. Violation of any of these rules and regulations will result in membership termination.
