Scholarship Application

2018-2019

First Presbyterian Preschool is excited to be able to offer scholarships to families enrolled in the preschool program. These funds are made available using the Preschool Angel Fund. A percentage of the Angel Fund will be devoted to awarding scholarships each year.

Program Details

- Scholarship deadline is **March 9, 2018**
- Students must be enrolled in the Preschool program to be eligible for the scholarship. The student's registration packet must be submitted, including the registration fee of \$125 and the supply fee of \$60, in order to reserve the child's enrollment
- Scholarship funds will be paid directly to First Presbyterian Preschool
- All scholarship recipients will be asked to complete a program agreement
- If any information is falsified on this application or supporting documentation, the scholarship will immediately be revoked and all monies dispersed must be returned to the Preschool for deposit in the Angel Fund
- Full and partial scholarships are not available to staff of First Presbyterian Church or First Presbyterian Preschool; these individuals should speak directly with the Preschool Director

Eligibility Requirements

- The child must be age eligible for a Preschool program being offered by First Presbyterian Preschool
- All students eligible for state funding through the Voluntary PreKindergarten (VPK) program must first apply for the VPK voucher. VPK wrap around services are eligible for payment with scholarship funds
- Aftercare fees are not eligible for payment using Angel Fund scholarship funds

- A family must meet the income guidelines as established and must provide supporting documentation. Documentation must be presented for all persons contributing to the household family income

Application Process

- Complete the First Presbyterian Preschool Scholarship Application and submit by March 9, 2018 for the 2018-2019 school year; information can be mailed to the following address:

- Applicants must submit a copy of the most recent income tax form
- Scholarship applications will be reviewed by the Director and the Preschool Application Review Committee
- All applicants will be notified of the Committee’s decisions by April 6, 2018
- Applicants who are approved for scholarships will receive a Scholarship Agreement. The Agreement must be completed and returned by April 20, 2018; if the agreement is not received by the deadline, the scholarship is considered null and void and the family will be responsible for making all tuition payments as outlined in the Preschool Tuition Agreement
- Incomplete applications or those received after the deadline will not be reviewed by Review Committee
- Decisions of the Review Committee are based on the order in which the application is received and the family income eligibility
- All information received during the scholarship process will be kept confidential, with applications being presented to the Review Committee blindly
- Our financial assistance fund is limited, and while we will review all applications that are received by the deadline that meet the income guidelines, we cannot guarantee that all applicants will receive assistance.
- Scholarships may be awarded for a full year or a partial year
