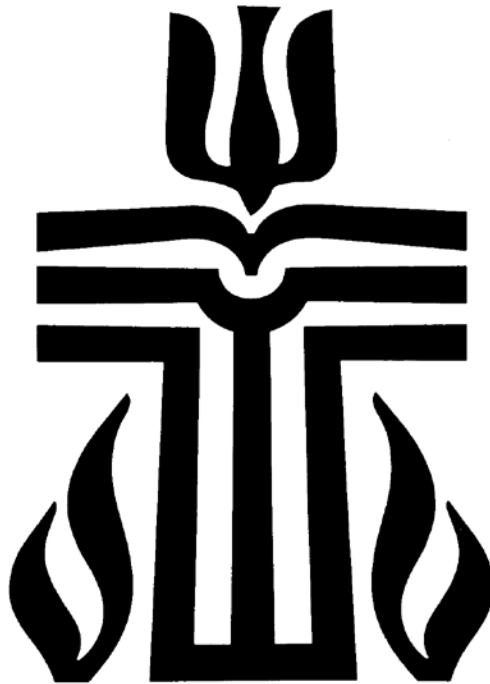

GUIDING COUNCIL

The Guiding Council shall be the coordinating body of the Presbytery. All budgets, financial matters, personnel policies, administrative matters, and long-range planning shall be cleared through the Guiding Council. The Guiding Council shall have the authority to act on matters between Presbytery meetings unless prohibited by the Book of Order or the standing rules of Presbytery.

The Guiding Council of the Presbytery of New Harmony shall consist of eleven members. The moderator of the Presbytery shall be an ex officio member. The moderators of the Finance, Personnel, and Property Committees, along with the Executive Presbyter, Associate Executive and the immediate past moderator of Presbytery will be members of the Guiding Council. In addition, there will be three members at large nominated by the Nominating Committee and elected by the Presbytery for three-year terms. The immediate past moderator of the Presbytery will serve as moderator of the Guiding Council.

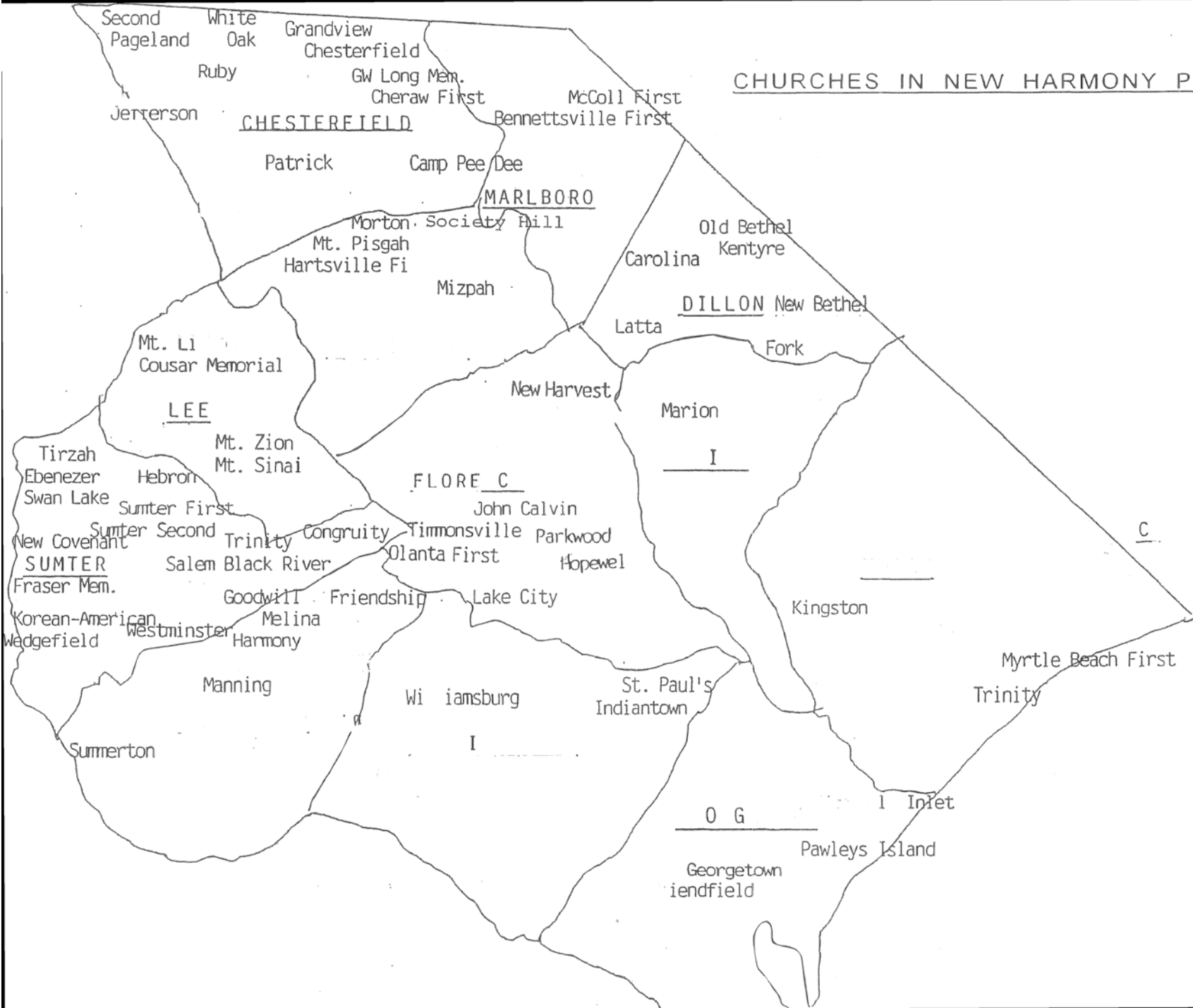
