

What is proof of a Certificate of Liability Insurance?

A certificate of **liability insurance** is a single sheet of paper that summarizes the benefits of an **insured** party's **insurance** policy. In short, it is **proof** of your **insurance coverage** and limit of your policy. Part of its value is that it contains extensive details about an **insurance** policy on a single sheet of paper.

What you need to tell the insurance company when calling for the certificate...

1. Name of Event – 2019 SWT Sr. High Youth Gathering
2. Place of Event – Camp Chrysalis 391 Upper Turtle Creek Rd., Kerrville, TX 78028
3. Date of Event – Feb. 8-10, 2019
4. Purpose of the Event – Sr. High School youth and their adult leaders gathering for learning events, leadership, and fellowship.
5. Estimate # of Youth & Adults
