

## CHURCH BOARDS

**SESSION:** (10 Nominees for Elder) – Moderated by Pastor; oversees the nine ministries of the church: Worship, Local and World, Adult, Youth, Families with Children, Welcome and Membership, Property, Finances, and Human Resources.

**DEACONS:** (11 Nominees for Deacon, plus 1 youth Deacons) - Moderated by Associate Pastor, ministers to those in need: the sick, friendless, and any in distress; offering care, support and sympathy in the name of Christ, witnessing to God's grace.

**Child Development Center: (CDC)** (numerous leadership positions) - Oversight of staff and operations of the Day Care Center. Special needs are for individuals with experience in education, child development, non profit, finance, or fundraising.

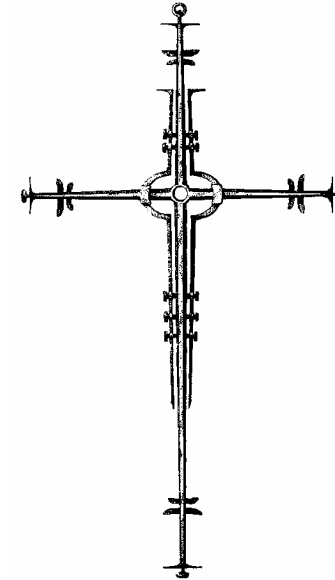
**Severna Park Community Center:** (2 Nominees) - Oversight and support of the staff and programs of the Community Center.

**Woods Counseling Center:** (2 Nominees) – Support and assistance to the staff and ministry of the Counseling Center.

**Woodwise Elderly Housing:** (2 Nominees) – Limited oversight of the Sunrise Senior Center, apportions, and ground rent. Special needs are for an attorney and for a graphics designer.

**2011 Nominating Committee:** (7 nominees) – Responsible for nominating the slate of church and board officers to be presented to the Congregation for election.
