- Sixteen hour training includes these topics: community resource and client needs assessment; networking; Bible study; covenants; principles of mentoring; and evaluation.
- Required reading prior to the training:
What Every Church Member Should Know About Poverty, Payne, Ruby K., Highlands, Texas. Aha! Process, Inc., 1999 (also available through amazon.com.)
- Participation in all sessions is required for certification. The Project Coordinator must be certified through participation in a National or South Carolina Certification training event prior to beginning a CWJC® or CMJC™ ministry.
- As a result of completing this training, individuals will be able to (1) know and recite the CWJC/CMJC purpose statement; (2) list and explain the key elements of a CWJC/CMJC ministry; (3) identify the steps to create and run a CWJC/CMJC ministry site; (4) articulate the purpose and skills necessary for a mentoring relationship; and (5) complete a ministry plan for organizing, operating, and evaluating a CWJC/CMJC ministry.
